**Please see messaging below being shared to the CSMC Medical/Dental Staff as it affects all practitioners with a Federal DEA prescriptive license.**

Dear AHS Medical Staff colleague,

The **MATE Act**, as part of the Omnibus bill of December 2022, established new **Medication-Assisted Treatment** training requirements. These requirements will apply to all practitioners seeking initial or renewal DEA registration beginning June 27, 2023. A copy of the letter from the DEA to registered practitioners is linked here:

As the letter outlines, a variety of resources may fulfill the **8-hour requirement** for training, if the requirement applies to you.
